### **Simulation game “Civil society and transitional justice”**

organized by Planpolitik (Simon Raiser and Elizabeth Floyd), Berlin/Washington

(Transitional justice is a response to systematic or widespread violations of human rights. It seeks recognition for victims and to promote possibilities for peace, reconciliation and democracy. Transitional justice is not a special form of justice but justice adapted to societies transforming themselves after a period of pervasive human rights abuse. (Simulating conflicts and negotiations provides a playful way of learning and understanding the political dynamics behind them. This is the exact goal of simulation games. After a negotiation or conflict situation has been chosen, the participants of the game proceed to assume the roles of the different parties and agents relevant to that situation. They have to represent their “character’s” interests convincingly and aim to make them prevail in negotiations. In order to achieve this, they must determine any existing scope for negotiation, use it to their advantage and recognise situations which call for compromise.
